- 3) All prices are subject to change without notice.
- 4) This price list supersedes previous pricing and programs.
- 5) Dealer agreement must be on file with Ice Rescue Systems to maintain dealer status.
- 6) Program qualifications required for all price levels. Not all program levels available outside the United States of America.
- 7) Ice Rescue Systems is not responsible for any price list printing errors.
- 8) M.A.P. Minimum Advertised Price applies to all Dealers who wish to sell Ice Rescue Systems products via the internet. Ice Rescue Systems strongly enforces MAP policy.
- M.S.P. Minimum Sell Price applies to all Dealers who sell lce Rescue Systems products. Ice Rescue Systems is committed to the integrity of the product.

PAYMENT TERMS

- 1) Net 10 days or Credit Card. Product minimum order is \$50.00 is required, Parts only orders is \$25.00, if the order is less than the minimum required dollar amount a \$25.00 service fee will be applied to the order.
- 2) We accept Visa, MasterCard, Discover, and American Express drawn on a United States bank. We reserve the right to charge 4% per transaction.
- 3) All payments are to be made in U.S. currency. For Credit Card payments the card must be drawn on a U.S. Bank, otherwise a 5% surcharge applies.
- 4) A \$75 service charge for "N.S.F." or returned checks for any reason. Replacement must be made in cash or cashier's check, including the fee and any freight charge back on order for account to be considered current.
- 5) A 1.5% service charge per month (18 % annually) on all accounts past due 30 days or more.

QUALIFIED PURCHASES:


